MECHANICAL PERMIT FEES

Mechanical permit fees shall be \$20.00 for the first \$1000.00 plus \$5.00 for each additional thousand or fraction thereof of the mechanical equipment, system and installation valuation. A fee of \$40.00 shall be paid for the re-inspection of a heating, ventilation, air-conditioning or refrigeration system, or boiler installation. When preliminary inspection is requested for purposes of permitting temporary operation of a heating, ventilating, refrigeration, or air-conditioning system, or portion thereof, a fee of \$15.00 shall be paid by the contractor requesting such preliminary inspection. If the system is not approved for temporary operation on the first preliminary inspection, a fee of \$15.00 shall be charged for each subsequent preliminary inspection for such purpose.

Boiler inspection fees shall be as follows (State permit may be required as well):

33,000 Btu (1 bhp) to 165,000 Btu (5 bhp): 5.00; 165,001 Btu (5bhp) to 330,000 Btu (10bhp): \$10.00; 330,001 Btu (10bhp) to 1,165,000 Btu (52bhp): \$15.00; 1,165,001 Btu (52bhp) to 3,300,000 Btu (98bhp): \$25.00; Over 3,300,000 Btu (98 bhp): \$35.00

*For SI: 1 British thermal unit (Btu) = 0.2931 W; 1 bhp = 33,475 Btu/hr

NOTICE: Permit fee refunds may not be available or may be limited.
