Beer Permit Application

By signing this application, the undersigned agrees to the following rules and regulations, as well as those in the attached ordinances as they may be amended and the statutes of the State of Tennessee as they may be amended. (PLEASE READ CAREFULLY)

- No person owning at least five percent (5%) interest in establishment nor any employee working in establishment, has been convicted of any violations of the laws of any state or any city for the possession, sale, manufacture, or transportation of intoxicating liquor; or of any crime involving moral turpitude within the last ten (10) years will be employed by establishment.
- No alcoholic beverages covered by this application will be sold, served, or given away by establishment between the hours of 3:00A.M. and 6:00A.M. on Monday, Tuesday, Wednesday, Thursday, Friday, and Saturday and between the hours of 3:00A.M. and 10:00A.M. on Sunday.
- No alcoholic beverage will be sold to minors and that no minors will be permitted to loiter at taverns or package stores as defined by Code.
- The beer permit will be surrendered to the City Recorder's Office within fifteen (15) days of the termination of establishment, change in ownership of establishment, relocation of establishment, or change of the name of establishment.
- If any false or misleading information is found in any material submitted to the beer board by or on behalf of an applicant for a beer permit, the application shall be cancelled and the applicant and any person who submitted false or misleading information shall not be permitted to apply for a beer permit for a period of ten (10) years from the date of the cancellation of the application. Upon evidence of making a false statement in this application, the permit would be forfeited and all persons who are determined to have made such false statements will be ineligible to receive any permit for a period of ten (10) years.
- A permit is only for a single location and is valid for all decks, patios, and other outdoor serving areas that are contiguous to the exterior of the building in which the business is located.
- If a new beer permit is requested in a name different than was originally issued and there is an ownership change, it is a different legal entity and must go through the entire process, including the \$250 application fee.
- Beer permits are non-transferable.

Additional Fees:

- A non-refundable fee of \$250 must accompany this application
- A privilege tax of \$100 is imposed on the business of selling, distributing, storing, or manufacturing beer in the state effective January 1, 1994 and each successive January 1. Any holder of a beer permit issued after January 1, 1994 shall pay a pro rata portion of this annual tax when the permit is issued.
- There will be a \$50 fee payable to the Maryville Police Department for fingerprinting.
- Required signage fee \$10. (Signs are provided by City of Maryville.)
