PUBLIC HEARING

REGULAR MEETING

The City Council of the City of Maryville convened for Public Hearings on June 4, 2019 at the Maryville Municipal Center at 6:50 p.m. where the following members were present: Mayor Tom Taylor presiding, Councilmen Fred Metz, Joe Swann and Andy White. Also present were City Manager Greg McClain, City Recorder Sherri Phillips, and City Attorney Melanie Davis. Councilman Tommy Hunt was absent. The Mayor declared a quorum to be present.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:50 p.m. regarding an ordinance of the City of Maryville, Tennessee adopting the annual budget, appropriating funds and providing revenues for the Fiscal Year beginning July 1, 2019 and ending June 30, 2020. At this time, the following citizens addressed the Council in regards to current Blount County Public Library funding:

There were no further comments so the Mayor declared the hearing closed.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:51 p.m. regarding the consideration of a resolution to declare the intent to levy a tax rate in excess of the certified property tax rate. There were no further comments so the Mayor declared the hearing closed.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:52 regarding an ordinance to abandon Alley #27 located off of Miller Avenue between Belle Street and Montvale Road. There were no further comments so the Mayor declared the hearing closed.

Thereupon, Council convened for regular business at 7:00 p.m. when the following members were present and answered roll call: Mayor Tom Taylor presiding, Councilmen Fred Metz, Joe Swann and Andy White. Also present were City Manager Greg McClain, City Recorder Sherri Phillips, and City Attorney Melanie Davis. Councilman Tommy Hunt was absent. The Mayor declared a quorum to be present.

At this time the Mayor declared June 20, 2019 as World Refugee Day in the City of Maryville, Tennessee.

Thereupon, it was moved by Councilman White and seconded by Councilman Metz to approve the minutes from the May 7, 2019 Council Meeting and the May 10, 2019 Called Council Meeting. On roll call the vote was unanimous.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on first reading:

AN ORDINANCE OF THE CITY OF MARYVILLE, TENNESSEE ADOPTING THE ANNUAL BUDGET, APPROPRIATING FUNDS, AND PROVIDING REVENUES FOR THE FISCAL YEAR BEGINNING JULY 1, 2019 AND ENDING JUNE 30, 2020.

Thereupon, it was moved by Councilman White and seconded by Councilman Metz that said ordinance be passed on first reading. On roll call the vote was unanimous. Thereupon, the Mayor declared that said ordinance had passed on first reading.

resolution had been adopted. The resolution was signed by the Mayor and City Recorder. The Mayor ordered said resolution numbered 2019-10 and recorded in the Resolution Book of the City.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on second reading:

AN ORDINANCE AMENDING THE ANNUAL OPERATING BUDGET OF THE CITY OF MARYVILLE, TENNESSEE FOR FISCAL YEAR 2019.

Thereupon, it was moved by Councilman Swann and seconded by Councilman Metz that said ordinance be passed on second reading. On roll call the vote was unanimous. Thereupon, the Mayor declared that said ordinance had passed on second and final reading and the Mayor ordered said ordinance numbered 2019-12 and recorded in the Ordinance Book of the City.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on second reading:

AN ORDINANCE AMENDING THE FY19 ANNUAL OPERATING BUDGET RELATIVE TO SCHOOL FUNDS.

Thereupon, it was moved by Councilman Metz and seconded by Councilman Swann that said ordinance be passed on second reading. On roll call the vote was unanimous. Thereupon, the Mayor declared that said ordinance had passed on second and final reading and the Mayor ordered said ordinance numbered 2019-13 and recorded in the Ordinance Book of the City.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on second reading:

AN ORDINANCE AMENDING THE CITY CODE RELATING TO THE REGULATIONS OF TAXI CABS.

Thereupon, it was moved by Councilman Swann and seconded by Councilman Metz that said ordinance be passed on second reading. On roll call the vote was unanimous. Thereupon, the

Mayor declared that said ordinance had passed on second and final reading and the Mayor ordered said ordinance numbered 2019-14 and recorded in the Ordinance Book of the City.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on second reading:

AN ORDINANCE TO ABANDON AN UNOPENED ALLEY LOCATED BETWEEN N. SUNSET DRIVE AND W. LAMAR ALEXANDER PARKWAY AND IDENTIFIED AS ALLEY #279.

Thereupon, it was moved by Councilman Swann and seconded by Councilman White that said ordinance be passed on second reading. On roll call the vote was unanimous. Thereupon, the Mayor declared that said ordinance had passed on second and final reading and the Mayor ordered said ordinance numbered 2019-15 and recorded in the Ordinance Book of the City.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on first reading:

AN ORDINANCE TO ABANDON ALLEY #27 LOCATED OFF OF MILLER AVENUE BETWEEN BELLE STREET AND MONTVALE ROAD.

resolution had been adopted. The resolution was signed by the Mayor and City Recorder. The Mayor ordered said resolution numbered 2019-11 and recorded in the Resolution Book of the City.

Thereupon, it was moved by Councilman Swann and seconded by Councilman Metz to consider a motion to authorize the Mayor to negotiate and renew the City Manager's employment contract. On roll call the vote was unanimous.

Thereupon, it was moved by Councilman Swann and seconded by Councilman White to consider a motion to approve an emergency contract authorized the City Manager for concrete work along E. Lamar Alexander Parkway to APAC-Atlantic, Inc. in the amount of \$58,390.00. On roll call the vote was unanimous.

Thereupon, it was moved by Councilman Swann and seconded by Councilman Metz to consider a motion to re-appoint Tony Crisp and Greg Cooke to the Blount County Emergency Communications District Board for a term to expire, July 1, 2023. On roll call the vote was unanimous.

Thereupon, there being no further business, the Mayor adjourned the meeting until the next scheduled meeting unless sooner called by the Mayor or as otherwise provided by law.

Thereupon, the consideration of a motion to grant a special event beer permit to Mary Kimberly Mitchell for the approved special event “Summer on Broadway” to be held in downtown Maryville from 5:00 pm, June 21, 2019 – 11:00 pm, June 22, 2019 and to include “Hops in the Hills” in Jack Greene Park from 5:00 pm – 11:00 pm, June 22, 2019 was considered. It was moved by Councilman Metz and seconded by Councilman Swann to grant said permit. On roll call the vote was unanimous. Thereupon, the Mayor declared that said motion carried and ordered said special event beer permit number 2019-01 issued.

Thereupon, the consideration of a motion to grant an on-premises beer permit to Christopher Mark Thompson, d/b/a Amici, 1420 E Broadway Ave, Maryville, TN 37804.
