PUBLIC HEARING AND REGULAR MEETING

The Maryville City Council convened for a public hearing and regular business meeting on July 6, 2021 at 6:56 p.m. when the following members were present and answered roll call: Mayor Andy White presiding, Councilmembers Sarah Herron, Tommy Hunt, Fred Metz and Drew Miles. Also present were City Manager Greg McClain, City Recorder Sherri Phillips, and City Attorney Melanie Davis. The Mayor declared a quorum to be present.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:56 p.m. regarding an ordinance of the City of Maryville, Tennessee to abandon a portion of an alley located between Springdale Street and Pinedale Street designated as Alley #475. There were no further comments, the Mayor declared the hearing closed.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:57 p.m. regarding an ordinance to abandon alleys located off S. Everett High Road designated as Alleys #245 and #246. There were no further comments, the Mayor declared the hearing closed.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:58 p.m. regarding an ordinance to abandon an alley located between McGhee Street and Lord Avenue designated as Alley #367. There were no further comments, the Mayor declared the hearing closed.

Thereupon, it was moved by Councilmember Herron and seconded by Councilmember Hunt to approve the minutes from the June 1, 2021 Council Meeting. On roll call the vote was unanimous.

Thereupon, it moved by Councilmember Metz and seconded by Councilmember Miles to consider a motion authorizing the renewal of a taxi cab franchise to Charles Henry Tyler, d/b/a Blount Taxi, 2836 New Blockhouse Road, Maryville, Tennessee 37803. On roll call the vote was unanimous. The Mayor declared that said motion had passed.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on first reading:

Thereupon, it was moved by Councilmember Hunt and seconded by Councilmember Metz that said ordinance be passed on first reading. On roll call the vote was unanimous. Thereupon, the Mayor declared that said ordinance had passed on first reading.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on first reading:

AN ORDINANCE TO ABANDON ALLEYS LOCATED OFF OF S. EVERETT HIGH ROAD DESIGNATED AS ALLEY #245 AND #246.

Thereupon, it was moved by Councilmember Hunt and seconded by Councilmember Miles that said ordinance be passed on first reading. On roll call the vote was unanimous. Thereupon, the Mayor declared that said ordinance had passed on first reading.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on first reading:

Thereupon, it was moved by Councilmember Metz and seconded by Councilmember Hunt that said ordinance be passed on first reading. On roll call the vote was unanimous. Thereupon, the Mayor declared that said ordinance had passed on first reading.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on first reading:

AN ORDINANCE AMENDING THE ANNUAL BUDGET OF THE CITY OF MARYVILLE, TENNESSEE FOR FISCAL YEAR 2022

Thereupon, it was moved by Councilmember Hunt and seconded by Councilmember Metz that said ordinance be passed on first reading. On roll call the vote was unanimous. Thereupon, the Mayor declared that said ordinance had passed on first reading.

Thereupon, it was moved by Councilmember Miles and seconded by Councilmember Hunt to consider a motion to approve a sole source contract with JAH Power Services, Inc. to install five (5) rebuilt network protectors for a cost of \$164,000. Upon roll call the vote was unanimous.

Thereupon, it was moved by Councilmember Hunt and seconded by Councilmember Metz to consider a motion to authorize the Mayor to sign a contract to purchase the licenses for the radio frequencies for the Meter Reading System from a sole source vendor, VIE Technologies, at a cost of \$61,209.00. Upon roll call the vote was unanimous.

Thereupon, it was moved by Councilman Hunt and seconded by Councilman Metz to approve a Mayoral re-appointment of Brian Boone and Chris Hackler to the Tree Board for a term to expire July 1, 2024. On roll call the vote was unanimous.

Thereupon, it was moved by Councilman Hunt and seconded by Councilman Miles to approve the Mayoral re-appointment of Gary Best, James Tomiczek and Mike Brown to the Maryville Board of Zoning Appeals for terms to expire July 1, 2025. On roll call the vote was as follows:

Thereupon, it was moved by Councilman Metz and seconded by Councilman Hunt to approve a Mayoral re-appointment of Suzette Donovan to the Maryville Planning Commission for a term to expire July 1, 2025. On roll call the vote was unanimous.

Thereupon, it was moved by Councilmember Miles and seconded by Councilmember Hunt to re-appoint Jane Groff to the Blount County Cable TV Authority for a term to expire July 2024. On roll call the vote was unanimous.

Thereupon, it was moved by Councilmember Hunt and seconded by Councilmember Metz to re-appoint Mike Davis to the Blount County Rescue Squad for a term to expire July 2024. On roll call the vote was unanimous.

Thereupon, it was moved by Councilmember Hunt and seconded by Councilmember Miles to declare certain items as surplus and to authorize their disposal. On roll call the vote was unanimous.

Thereupon, it was moved by Councilmember Hunt and seconded by Councilmember Metz to consider a motion authorizing three (3) Crown Victorias previously declared as surplus to be donated to Blount County for use at the driving range, which is used by all local Police Departments. On roll call the vote was unanimous.

Thereupon, it was moved by Councilman Hunt and seconded by Councilman Metz to approve the Mayoral appointment of Brownlow Marsh to the Maryville Housing Authority for a term to expire July 2025. On roll call the vote was unanimous.

Thereupon, there being no further business, the Mayor adjourned the meeting until the next scheduled meeting unless sooner called by the Mayor or as otherwise provided by law.
