PUBLIC HEARING AND REGULAR MEETING

The Maryville City Council convened for a public hearing and a regular business meeting on September 1, 2020 at 6:54 p.m. when the following members were present and answered roll call: Mayor Tom Taylor presiding, Councilmen Tommy Hunt, Fred Metz and Joe Swann. Councilman Andy White was absent. Also present were City Manager Greg McClain, City Recorder Sherri Phillips, and City Attorney Melanie Davis. The Mayor declared a quorum to be present.

Thereupon, it was moved by Councilman Metz and seconded by Councilman Hunt to approve the minutes from August 4, 2020 Council Meeting. On roll call the vote was unanimous.

THEREUPON, THE FOLLOWING PROCEEDINGS WERE HAD AND ENTERED OF RECORD TO-WIT:

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:54 p.m. regarding an ordinance to amend the future land use map of the City of Maryville, Tennessee by designating a portion of Parcel 015.00 on Blount County Tax Map 0581 Group A, located off S. Cedar Street, as Mixed Use. There were no further comments so the Mayor declared the hearing closed.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:55 p.m. regarding an ordinance to amend the Zoning Map of the City of Maryville, Tennessee by rezoning a portion of Parcel 015.00 on Blount County Tax Map 0581 Group A, located off S.

Cedar Street, from Residential to Neighborhood. There were no further comments so the Mayor declared the hearing closed.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:56 p.m. regarding a resolution to annex portions of property located off W. Broadway Avenue and Westside Drive (Blount County Tax Map 068C, Group A, Parcels 019.00 & 021.00) to incorporate the same within the corporate boundaries of the City of Maryville, Tennessee. There were no further comments so the Mayor declared the hearing closed.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:57 p.m. regarding the plan of services for the proposed annexation of portions of property located off W. Broadway Avenue and Westside Drive (Blount County Tax Map 068C, Group A, Parcels 019.00 & 021.00). There were no further comments so the Mayor declared the hearing closed.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:58 p.m. regarding an ordinance to amend the Future Land Use Map of the City of Maryville, Tennessee by designating portions of property off W. Broadway Avenue and Westside Drive (Blount County Tax Map 068C, Group A, Parcels 019.00 & 021.00) as Commercial. There were no further comments so the Mayor declared the hearing closed.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:59 p.m. to amend the Zoning Map of the City of Maryville, Tennessee by zoning portions of Parcel 019.00 & 021.00 on Blount County Tax Map 068C, Group A, located off Westside Drive and W. Broadway Avenue. There were no further comments so the Mayor declared the hearing closed.

On roll call the vote was unanimous.

Thereupon, it was moved by Councilman Hunt and seconded by Councilman Metz to consider a motion to approve the emergency purchase of a Liebert 30 kVA/20 kW UPS (Uninterruptible Power Supply) and upgraded electrical circuit. On roll call the vote was unanimous.

Thereupon, it was moved by Councilman Swann and seconded by Councilman Hunt to consider a motion for the re-appointment of Matthew N. Murray, Gary Hensley, and Charles

Alexander to the Board of Directors of the Blount County Partnership Economic Development Board with a term to expire in July, 2026. On roll call the vote was unanimous.

Thereupon, it was moved by Councilman Metz and seconded by Councilman Hunt to consider a motion for the re-appointment of Chad Rochelle to the Board of Directors of the Smoky Mountain Tourism Development Authority with a term to expire July, 2026. On roll call the vote was unanimous.

Thereupon, it was moved by Councilman Swann and seconded by Councilman Metz to consider a motion to declare certain items as surplus and to authorize their disposal. On roll call the vote was unanimous.

Thereupon, it was moved by Councilman Metz and seconded by Councilman Swann to consider a motion to approve the sale of Parcel #057d E 048.00 located on McNabb Place, Maryville, Tennessee. On roll call the vote was unanimous.

Thereupon, there being no further business, the Mayor adjourned the meeting until the next scheduled meeting unless sooner called by the Mayor or as otherwise provided by law.
