## PUBLIC HEARING AND REGULAR MEETING

The Maryville City Council convened for a public hearing and regular business meeting on December 7, 2021 at 6:58 p.m. at the Maryville Municipal Center when the following members were present: Mayor Andy White presiding, Councilmembers Sarah Herron, Tommy Hunt, Fred Metz and Drew Miles. Also present were City Manager Greg McClain, City Recorder Sherri Phillips, and City Attorney Melanie Davis. The Mayor declared a quorum to be present.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:58 p.m. regarding an ordinance to amend Sections §14-209 and §14-218 of Title 14 of the Maryville Municipal Code, The Zoning and Land Use Ordinance, pertaining to backlighting of signs, within the City of Maryville including the Downtown Districts. There being no further comments, the Mayor declared the hearing closed.

Thereupon, the Mayor declared the Council in session for a Public Hearing at 6:59 p.m. regarding an ordinance to abandon an alley located between Kittrell Avenue and Sevierville Road and designated as Alley #206. There being no further comments, the Mayor declared the hearing closed.

Thereupon, the Maryville City Council convened for a regular business meeting on December 7, 2021 at 7:00 p.m. at the Maryville Municipal Center when the following members were present and answered roll call: Mayor Andy White presiding, Councilmembers Sarah Herron, Tommy Hunt, Fred Metz and Drew Miles. Also present were City Manager Greg McClain, City Recorder Sherri Phillips, and City Attorney Melanie Davis. The Mayor declared a quorum to be present.

At this time, the Mayor recognized Boy Scout Troop 800, Sycamore United Methodist.

Thereupon, it was moved by Councilmember Hunt and seconded by Councilmember Miles to approve the minutes from the November 2, 2021 Council Meeting. On roll call the vote was unanimous.

At this time, Mark Pulliam, 1909 S. Whitehall Street, Maryville, Tennessee, addressed Council in opposition to the proposed Cross Creek development and overdevelopment in the City of Maryville.
