Electrical Service Work Permits & Fees

The type of electrical service and fees required will be dependent upon the work being performed or the type of problem that occurs. The most common electrical services include: meter pull, cutloose, and work orders.

Meter Pull

A meter pull consists of a service technician temporarily removing the electric meter to interrupt power. Meter pulls are usually requested to replace a main breaker, check the condition of the meter socket, or make minor changes inside the home. Fees may apply. If an inspection is required, the work and the inspection must be completed before 3:30 p.m. and all applicable fees paid. To schedule a meter pull, please call (865) 273-3456. Please allow a 24-hour notice so our service technicians can adjust their schedules accordingly.

Cutloose

A cutloose is typically required for a service upgrade, change out, broken pole, large fire, siding repairs, storm damage*, panel change, and tree trimming.** If any changes need to be made in the meter pan, then a cutloose will be required. If an inspection is required, the work and the inspection must be completed before 3:00 p.m. to have the lines connected back for service the same day. Once permits are in place, inspections are scheduled, and fees are paid, please call (865) 273-3474 or (865) 273-3456 to schedule a cutloose. Please allow a 24-hour notice so our service technicians can adjust their schedules accordingly.

Work Orders

Work orders are for more advanced jobs requiring more planning such as changing from overhead to underground services, installing new transformers, and installing electric services in new subdivisions. Fees for work orders vary based on the work being done. Estimates are provided by the electrical engineers at our Operations Center and can be attained by calling (865) 273-3300 and asking to speak with an Electrical Engineer.

Requesting a Permit

It is the responsibility of the person requesting the permit to make sure to determine if the location is INSIDE or OUTSIDE the City Limits of Maryville before applying and paying for the permit. Not all fees are refundable, so if you need assistance determining where to request the permit please call (865) 273-3456. If you need help determining what permits are needed, then please call the inspector for your location at the numbers listed at right.

*Fees and inspection rules may change when storm damage is involved.
