PUBLIC HEARING
AND
REGULAR MEETING

The Maryville City Council convened for a public hearing and regular business meeting on June 6, 2023, at 6:55 p.m. at the Maryville Municipal Center when the following members were present: Councilmembers Sarah Herron, Tommy Hunt and Vice-Mayor Fred Metz. Councilmember Drew Miles and Mayor Andy White were absent. Also present were City Manager Greg McClain, City Recorder Sherri Phillips, and City Attorney Melanie Davis. The Vice-Mayor declared a quorum to be present.

Thereupon, the Vice-Mayor declared the Council in session for a Public Hearing at 6:55 p.m. in regard to the consideration of a resolution to declare the intent to levy a tax rate in excess of the certified property tax rate. There were no further comments, the Vice-Mayor declared the hearing closed.

Thereupon, the Vice-Mayor declared the Council in session for a Public Hearing at 6:56 p.m. in regard to the consideration of an ordinance of the City of Maryville, Tennessee adopting the annual budget, appropriating funds and providing revenues for the fiscal year beginning July 1, 2023 and ending June 30, 2024. There were no further comments, the Vice-Mayor declared the hearing closed.

Thereupon, it was moved by Councilmember Hunt and seconded by Councilmember Metz to approve the minutes from the May 2, 2023 Council Meeting. On roll call the vote was unanimous.

At this time Linda Wade, 213 S Cedar Street, Maryville, Tennessee, addressed the Council in regard to previous complaints of muffler noise around Maryville High School.

At this time Bonny Millard, 415 Willard Street, Maryville, Tennessee, addressed the Council in regard to fireworks.

Thereupon, the following captioned resolution was presented, considered, and placed for adoption:

Thereupon, it was moved by Councilmember Herron and seconded by Councilmember Hunt that said ordinance be passed on second reading. On roll call the vote was unanimous. The Vice-Mayor declared that said ordinance had been adopted. The ordinance was signed by the Vice-Mayor and City Recorder. The Vice-Mayor ordered said ordinance numbered 2023-13 and recorded in the Ordinance Book of the City.

Thereupon, the following captioned ordinance was presented, considered, and placed for passage on first reading:

AN ORDINANCE AMENDING THE ANNUAL OPERATING
BUDGET OF THE CITY OF MARYVILLE, TENNESSEE FOR
FISCAL YEAR 2023.

Thereupon, it was moved by Councilmember Herron and seconded by Councilmember Hunt that said ordinance be passed on first reading. On roll call the vote was unanimous. Thereupon, the Vice-Mayor declared that said ordinance had passed on first reading.

Thereupon, the following resolution was presented, considered, and placed for adoption:

A RESOLUTION AUTHORIZING THE SPECIAL EVENT
"SUMMER ON BROADWAY" TO BE HELD FROM 5 PM, JUNE
23, 2023, UNTIL 11 PM, JUNE 24, 2023.

Thereupon, it was moved by Councilmember Herron and seconded by Councilmember Hunt that said resolution be adopted. On roll call the vote was unanimous. The Vice-Mayor declared that said resolution had been adopted. The resolution was signed by the Vice-Mayor and City Recorder. The Vice-Mayor ordered said resolution numbered 2023-11 and recorded in the Resolution Book of the City.

Thereupon, it was moved by Councilmember Herron and seconded by Councilmember Hunt to consider a motion to approve a sole source contract with JAH Power Services, Inc. for the installation of (2) network transformers, protectors, and associated materials on the downtown underground network electric distribution system at a cost of \$42,828.00. Upon roll call the vote was unanimous.

Thereupon, it was moved by Councilmember Herron and seconded by Councilmember Hunt to declare certain items as surplus and to authorize their disposal. On roll call the vote was unanimous.


Thereupon, it was moved by Councilmember Herron and seconded by Councilmember Hunt to consider a motion to move the regular Council Meeting due to the July 4th holiday from Tuesday, July 4 to Wednesday, July 5, 2023. On roll call the vote was unanimous.

Thereupon, it was moved by Councilmember Hunt and seconded by Councilmember Herron to consider a motion to allow the City Manager to enter into contract with the Violent Crime Intervention Fund in the amount of \$157,929.00. This is a reimbursement grant that will return the funds spent. On roll call the vote was unanimous.

Thereupon, there being no further business, the Vice-Mayor adjourned the meeting until the next scheduled meeting unless sooner called by the Mayor or as otherwise provided by law.




