CITY OF MARYVILLE CODES ENFORCEMENT

All or some of the following field inspections are required for this project:

Building/Plumbing: Residential- Robert Large- 865-273-3516 or wrlarge@maryville-tn.gov

Commercial- Maria Nelson- 865-273-3513 or manelson@maryville-tn.gov

- Footing-** prior to pouring footings
- Rough- in plumbing under slab-** prior to covering, need pressure test
- Concrete Slab-** after moisture barrier in place prior to pouring
- Framing-** prior to covering with insulation and exterior covering
- Plumbing Rough-in-** prior to covering with insulation and/or wall board, need pressure test on all systems
- Insulation (residential) -** after insulation, windows and doors are installed but before covering insulation with drywall. Windows & doors may be inspected on final inspection if labels are intact.
- Fire Resistive Assemblies-** after all through penetrations are fire-stopped as per approved system. System specifications for each type penetration will be required on site at inspection
- Final Plumbing-** after all fixtures are set are properly functioning and cross-connection prevention working
- Final Building-** after all building elements are in place and address numbers installed on building at front door
- Retaining Walls –** foundation and final with engineer's stamped approval

- Temporary Service**
- Concrete Slab-** prior to covering
- Rough-in-** prior to covering with insulation and / or wall board
- Buried Conduit-** prior to covering
- HVAC-** after equipment is in place and electrical connections made
- Final-** when all electrical work is completed

- Rough-in-** prior to covering with insulation and / or wall board
- Final –** upon completion/installation of all mechanical systems
